Virginia state law states you **MUST** provide adequate shelter, veterinary care, and daily food and water for a domestic animal. Adequate shelter means protection from cold, rain, heat and sun. Also, your animal must be under complete control at all times. **At four months of age, your dog must be vaccinated against rabies and must be licensed and your cat must be vaccinated against rabies. Virginia state law also states that all animals that are released from adoption agencies must be spayed and neutered.** Costs associated with animal ownership other than the adoption fee include proper food, veterinary exams, emergency vet visits, injury, vaccinations, spaying/neutering and yearly licensing. GMHS strongly believes that animals are part of the family and need attention and love.

I understand that the GMHS is not financially responsible for veterinary care for this animal. I also understand the GMHS cannot and does not guarantee the health of this animal, and I hold them blameless for any problems associated with the animal's health. I also understand the GMHS cannot reserve an animal for me to adopt, nor does this application serve as a formal agreement to adopt an animal to me.
